#### PERSONAL STATEMENTS FROM POTENTIAL SGR ADVISORS

#### **Marion Hersh**

I believe that scientists and engineers have a responsibility to use their expertise to benefit society and the environment and rectify the damage caused in the past. This includes climate change and nuclear weapons, both caused by human activity.

I am a long-term member of SGR and actively involved in my trade union and other campaigning organisations. I am a senior lecturer in biomedical engineering at Glasgow University with a first degree in mathematics and PhD in control engineering and speak eight languages reasonably fluently.

I have researched in several areas of interest to SGR, including ethics of military work and, more recently social impacts and ethics of AI, have edited and contributed to a book on ethical engineering, and coauthored a book of ethics and human behaviour with mainly ICT case studies.

I can both focus on detail and make links and see connections that others often miss.

## **Philip Inglesant**

I am seeking re-election to the SGR Advisory Board. I have been very inspired by the activities of SGR, with a reach and impact far beyond to the small size of the organisation.

My background is in computing. I worked for many years with GreenNet, a not-for-profit Internet Service Provider supporting peace, the environment and human rights. At that time I was involved with Electronics and Computing for Peace, one of the predecessor organisations of SGR.

More recently, I have been researching Responsible Innovation in quantum computing and Artificial Intelligence. I am passionate about the importance of social responsibility in science, and in keeping military influence out of universities.

I bring to SGR my experience in working and researching in these areas. With the massive explosion of AI, the social and environmental implications of this is now an urgent area of work.

#### Fiona McOwan

I joined SGR while I was a chemistry teacher at a high school in Fife as I was so pleased to find an organisation of scientists who believed that we need to protect the planet and its peoples. Their values aligned with mine as a member of the Women's International League of Peace and Freedom (WILPF UK).

I am anti-war and militarism, anti-continuing fossil fuel extraction, anti-nuclear for energy or warfare. I am for renewable energy, with arms manufacturers and oil workers transitioning to research and making the complex parts for renewables infrastructure.

Having been an advisor for a year, nothing has changed my mind, and I am keen to support the Board by amplifying messages, contributing ideas and spreading knowledge of SGR to my wider contacts in the education field, and occasionally writing thought pieces for the website and journal.



#### DRAFT MINUTES OF THE ANNUAL GENERAL MEETING HELD ON

#### 1. Opening Remarks

Jan Maskell (Co-Chair of the SGR Board of Directors) opened the SGR 2024 Annual General Meeting by welcoming all the attendees, and thanked the conference speakers and organisers.

#### 2. Minutes of SGR AGM 2023

The minutes were agreed as a correct record (proposed by Richard Erskine, seconded by Steve Ballard). There were no matters arising.

### 3. Annual Report and Accounts (1 March 2023 – 29 February 2024)

Stuart Parkinson (SP) (Executive Director) presented a summary of SGR's main outputs over the year, more of which can be found in the Annual Report available on the SGR website. Highlights included:

- New SGR technical report on UK military emissions published written by SP
- SGR's work repeatedly quoted by House of Commons Defence Committee report, including some recommendations
- SP spoke at and helped organise international hybrid conference on military emissions on a panel with head of climate at MOD
- Nico Edwards wrote report for World Peace Foundation on green militarism
- SGR's work used for lobbying at UN FCCC technical meetings in Bonn
- Supported campaigns against new coal/oil/gas projects especially in UK
- New book by Andrew Simms (AS): 'Badvertising'
- 'Fair Lifestyle Targets' rebranding of '1.5C Living Targets' to emphasise equity and reflect continuing failure to reach 1.5C pathway; promotional videos by Liam Killeen
- 'Carbon Conversations' run by Jan Maskell (JM)as part of 'Closing Loops' sustainable food project
- Numerous talks given including at Green Gathering, Green New Deal Summit, Festival of Survival in Glasgow

- Journal article by Phil Webber (PW) and SP documenting high intensity bombardment of Gaza by Israeli military – one of most destructive in history, using AI to speed up 'target selection'; over 6,000 page-views on website
- Teachers' packs on nuclear weapons by PW and JM launched to coincide with 'Oppenheimer' movie – 500+ downloads
- SGR supported Drone Wars workshop on military R&D into human enhancement, so-called 'cyborgs'
- Co-signed numerous calls for ceasefires, peace etc in Gaza and elsewhere
- Continuing high level of social media activity, and coverage in Guardian and other high profile news media, including SP in a TV debate on an Al-Jazeera prime-time show

Emily Heath (Finance & Membership Manager) presented a summary of the annual accounts.

Income over the year was approx. £62k – a 33% increase compared to the previous year, mainly due to successful grant applications supplemented by some consultancy income. Expenditure for the year was approx. £66k – a 12% decrease compared to the previous year, mainly due to a major project (our Responsible Science Campaign) having ended. There was a deficit of approx. £4k over the year, but £2.5k of that was due to a delay in receipt of funds from the 2023 Annual Appeal, to be recouped in the next financial year. Overall SGR ended the financial year with a balance of approx. £27k.

The accounts were accepted unanimously, having been proposed by Andrew Lohmann and seconded by Andrew Simms.

Questions were invited from participants, but there were none.

#### 4. Election of Advisors to the Board of Directors

Several Advisors are invited to SGR Board meetings in a non-voting capacity and participate fully in discussions about SGR's activities. They can either be elected at an AGM or co-opted by the Board at other times.

Nico Edwards, Fiona McOwan and Philip Inglesant have all served as Advisors over the past year, and all had confirmed their willingness to continue. They were jointly elected at this AGM, having been proposed by Keith Baker and seconded by Charalampos Tsoumpas.

Steve Ballard asked about the accountability of the Directors, and how they are elected or appointed. Emily responded that SGR is now governed in accordance with the Articles of Association that were agreed by members at the 2022 AGM, and implemented since SGR became a Company Limited by Guarantee in March 2023. Six initial directors were elected by members at the 2022 AGM and are all still in place. They are Philip Webber (co-chair), Jan Maskell (co-chair), Keith Baker and Simon Reed, plus two ex-officio directors, Stuart Parkinson and Emily Heath. In future, new directors will be appointed by the Board rather than being elected at the AGM. Phil added that Directors periodically resign in rotation so that the others can choose whether to re-appoint them.

Members are welcome to express an interest in becoming an Advisor or Director.

SGR's accounts are independently examined and reported annually to Companies House.

#### 5. Update on Recent/Current Activities

Stuart Parkinson reported on recent and current activities (March-October 2024), including:

- Work on sports and climate, e.g. researching the carbon footprint of the international football industry and 'sportswashing' by the fossil fuel industry
- Promoting blogs by scientists ahead of the recent general election, focused on what the new political priorities should be
- Contributing to a new book called 'Monstrous Anger of the Guns'
- Working to expose the scandal of an academic who was sacked for refusing to fly
- Supporting sign-on letters on a range of issues including arms sales to Israel
- Rowan Harris has replaced Liam Killeen as our Communications Assistant.

Questions were invited from participants.

Richard Erskine asked how SGR decides which issues to focus on, and how we can bring a greater diversity of voices into our campaigning, e.g. including those from Africa. Stuart responded that we are still primarily a UK-based organisation, but accepted the need for increased diversity, and would welcome ideas about how to achieve this. SGR focuses mainly on issues that our active members have expertise in, and identifies gaps that other NGOs are not addressing, playing to our strengths as a science-led organisation.

Phil Webber asked how we can give more weight to campaigning for the rapid transition to wind, water and solar (WWS) energy and green energy storage solutions – and against the much more costly, polluting, and energy-inefficient technologies like Carbon Capture and Storage, Direct Air Capture, etc - that Mark Jacobson outlined in his conference presentation. Stuart responded that Mark will be invited to contribute to the next edition of our Responsible Science journal and that we hope to work with him further.

The AGM ended at 6.50 pm.
